

2020 Qualified Candidate Expense Reimbursement And Event Attendance Information

NOTE: All reimbursement or covered expenses as set forth below will be made to candidates that have met the candidate qualification process as set forth in the 2020 Election Candidate Guidelines and shall be subject to the primary voting rules in the event that more than four candidates are duly nominated and seconded prior to December 15, 2019. No expenses shall be submitted for reimbursement prior to meeting viable candidate status. If eligible expenses are incurred by a candidate prior to reaching viable status, then the candidate may submit these previously incurred expenses at the time that the candidate viability has been met for reimbursement.

1. 2020 PGA Merchandise Show (January 2020)

- a. The PGA shall not reimburse travel expenses to the PGA Merchandise Show.
- b. The PGA may provide the Candidates the ability to meet the Delegates in a general setting.
- c. No hospitality for candidates is provided during the PGA Merchandise Show.

2. Super Regional Meetings

- a. The PGA will fund the cost of conducting Super Regional Meetings, including the travel of the Section Delegates, Past Presidents and District Directors to those meetings. There will be four Super-Regional meetings as set forth in the 2020 Election Candidate Guidelines.
- b. Travel reimbursement for the Candidates and authorized support individual is set forth in the 2020 Election Candidate Guidelines.
- c. The Board of Directors will define the format for the Super Regional Meetings and will ensure that each Candidate will receive ample exposure with the Delegates.

3. PGA Magazine Candidate Profiles (Summer, 2020)

a. PGA Magazine will publish profiles of each Candidate in a Summer issue of PGA Magazine.

5. PGA of America Spectator Championships

NOTE: Applies only when a PGA Board Member is a Candidate

- a. No travel costs will be reimbursed to a Candidate for the events listed below. Candidates and spouse or guest that wish to attend shall be provided credentials, based on space availability, that allow access to PGA of America hospitality venues accessible to the Board of Directors:
 - i. 102nd PGA Championship
 - ii. 43rd Ryder Cup

6. 104th PGA Annual Meeting (November 2020)

- a. Travel costs will be reimbursed as stated in the 2020 Election Candidate Guidelines
- b. A private session of 15-30 minutes will be scheduled for each Candidate to meet with the PGA Past Presidents as a group.
- c. A Candidate Forum will be conducted during the Informal Session of the Annual Meeting.
- d. Candidate hospitality will be provided in each Candidate Hospitality room with a standard set. Candidates may not bring in additional food and beverage.
- e. Nomination speeches will be given during the Annual Meeting General Session.
- f. For the Candidate elected as the new Secretary, the Association does cover the expenses of the new Secretary's team dinner for all attendees, up to 40. The normal approved expense is \$150 per person.
- g. In regard to the team dinner for the other Candidates, the Association will pay that same cost, within reason of the \$150 per person allowed, for those attendees who would normally be reimbursed. This would include the Candidate and Spouse/Guest, official Candidate Support person and Spouse/Guest, and anyone else falling within the reimbursement policy, such as the Section Executive Director, a Section Officer or National Board Member. For those not included in the normal reimbursement contingent, those expenses would not be reimbursed by the Association.
